



ALTERNATIVE Embalmer Application Checklist & Instructions

If you are exiting directly from the provisional program, this application is NOT for you.

Read all requirements and instructions carefully.

- This application is open only to a person who previously held a provisional license in Texas within the 24 months prior to filing this application that has been set to NULL & VOID or CANCELLED.
- Has already successfully performed 45 cases is required, 10 of which must have been complete cases. A complete embalming case means handlings all major actions included in TAC§203.32 performed on a particular body.
- The last case performed must not be more than 24 months old.
- The case report logs must be completed and each case signed by the person who supervised the case and the FDIC/EIC.

In order to be considered for licensure, please submit the following:

- APPLICATION FOR EMBALMER LICENSE.** All sections must be complete. If you answered yes to either question 1 or 2 on page one of the application, complete the “Criminal History Questionnaire for Applicants” Form and submit all requested information.
- FEE.** The application **fee is \$93.00.** Make check or money order payable to the Texas Funeral Service Commission (credit cards not accepted). **Application fees are non-refundable.**
- PROOF OF GRADUATION FROM HIGH SCHOOL OR GED CERTIFICATES**
Submit official/certified transcript from high school from which you graduated or GED certificates.
- PROOF OF GRADUATION FROM AN ACCREDITED MORTUARY SCHOOL OR COLLEGE.**
Submit official/certified transcript from the Mortuary School from which you graduated.
- TEXAS MORTUARY LAW EXAM SCORE AND DATE TAKEN.** Under Tex. Admin. Code, Title 22, Part 10, Rule 203.1(3), an applicant must *re-take* and pass the State Mortuary Law Exam, upon application for full licensure.
- NATIONAL BOARD EXAMINATION SCORE.** Submit official scores from The International Conference of Funeral Service Examining Boards for National Board Examination – Science.
- CASE LOGS.** Submit copies of case report logs showing 45 total cases with 10 completes. Each case must be signed by person who supervised the work and the log must be signed by the FDIC/EIC of the establishment. The last case performed must not be more than 24 months old.
- FBI BACKGROUND CHECK.** Due to DPS security policies, once your application and fee has been received, staff will email you with the instructions on obtaining your background check. Please make sure you submit your application with a **valid & legible** email address as this is where the instructions will be sent.

Incomplete applications or applications submitted without fees will not be processed and will be returned to the applicant with no action taken.

NOTE: It is unlawful to practice embalming in the state of Texas without a valid embalmer’s license.
